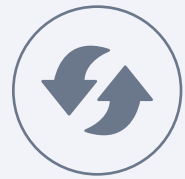

SEAMLESS PAYMENT

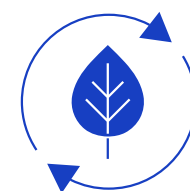
Your carbon offsetting payment is included in the cost of your flight. This will be listed as "Carbon Offsetting".
